A reinforced concrete pad at least four to six inches thick or a structurally sound deck is needed to support the "dead weight", found in the spa specification chart of the Pre-Delivery Guide, is recommended. Refer to your Pre-Delivery Guide for other foundations or proper support that is acceptable for your specific product. Swim Spas should be place on a reinforced rebar concrete pad at least 6 to 8 inches thick, depending on the size of the unit. Refer to your Pre-Delivery Guide. 2. A site visit from Mainely Tubs is required for all swim spa installations. 3. Delivery crews do NOT level or prepare spa sites. ACCESS AND CLEARANCE 1. Depending on the size, your spa requires minimum clearances to travel through gates, between the house, side fences, doorways, etc. 2. Decks over 5 steps, or 6 feet high, may require additional equipment and charges may apply. 3. The distance required to turn a corner should be equal to the length of the spa. 4. All debris limiting or blocking access to the job site must be removed prior to delivery. Any trimming of trees or bushes, removal of debris, leveling of ground or other general maintenance must be done prior to delivery. 5. Mainely Tubs is not responsible for any damage resulting from clearances of less than 6" greater of width or height of the hot tub dimensions. 6. It is the responsibility of the customer to provide at least 36" clearance to the front panel or additional fees may apply. 7. Clearance for the installation & operation of the cover lifter must be provided. DELIVERY AND SET UP 1. Please call the Delivery Coordinator at (207)883-6357 ext. 3 to schedule your delivery. 2. The time required to set up your spa varies due to each job's complexity; however, 1-2 hours is usually the time required. It is impossible for us to guarantee an exact arrival time; all deliveries and set up times are approximate on delivery day. 3. Delivery appointments that are cancelled within 1 business day (M-F), or cancelled on Saturday/Sunday for Monday deliveries, are subject to a \$650 redelivery fee. 4. If we attempt to deliver and discover a crane is necessary or that the site is not fully prepared, there will be a \$650 charge for the second attempt and \$650 for subsequent delivery attempts. Crane charges are the responsibility of the BUYER. The hot tub or Swim Spa will be placed as close as possible to the site location, if a redelivery is not requested. 5. Delivery crews will NOT wait for site preparation or electrical if it will delay them at the time of delivery. 6. Our delivery includes: Installation of product to your prepared designated site; Supervise any crane or deck winch installations, as per contract; Orient per customers directions; Install cover and cover safety clips; Install spa accessories purchased prior to delivery from Mainely Tubs; Give customer overview of the primary functions and operations; Review owner's manual for exact startup procedures and any applicable accessory manual(s); Chemical system orientation and reviewing initial chemical startup procedures; Review point-of contact for startup issues or questions; Review serial number and customer delivery statement; Clean and remove all garbage and debris.
